Grow Solar has an official installer to save money. Works with IRA (inflation reduction act) to help people see incentives and easy how to install. Ideas- SOLAR House Tour on a specific time or self guided walking tour. People want to know cost to lets share what we know,

#### Councilwoman Pam Bliss Update

1. BUDGET Pam- Nation League of Cities, NLC- great resources to help cities apply for grants, IRA, You have to have a current plan in place to apply for grants to use without a structure behind it. That's why we need a plan for ARP money. Dr. Peoples and staff can implement it. With 100K we use 5,500 for greenhouse gas inventory, 25K for stormwater management plan, 25K to implement projects, 25K green dining alliance, 25K for education to learn about EV charging or solar installations in homes. Grow Solar program that helped businesses and home is coming back! Dr.
